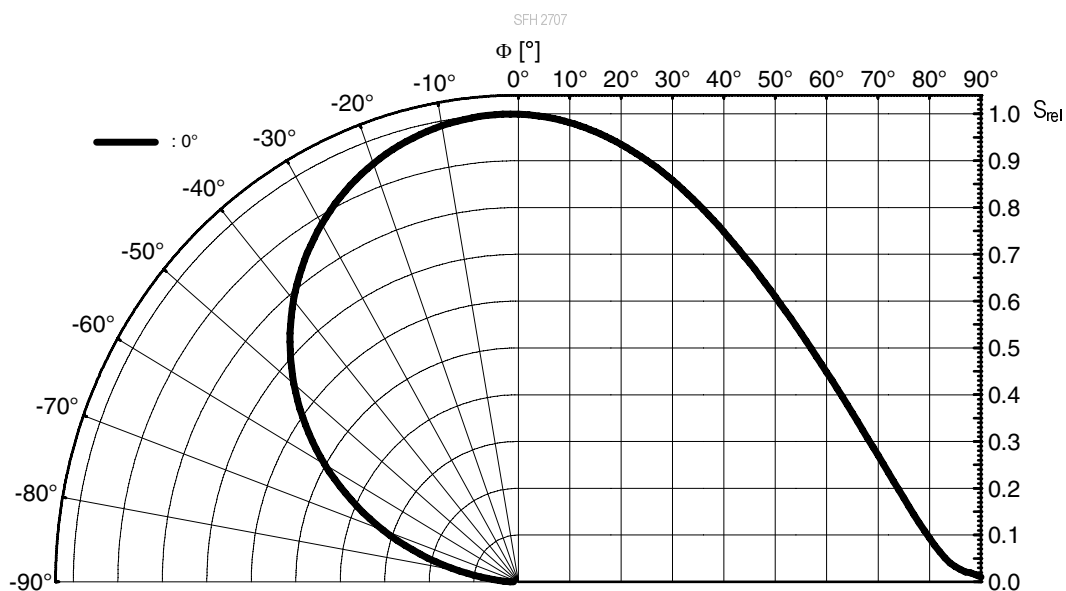

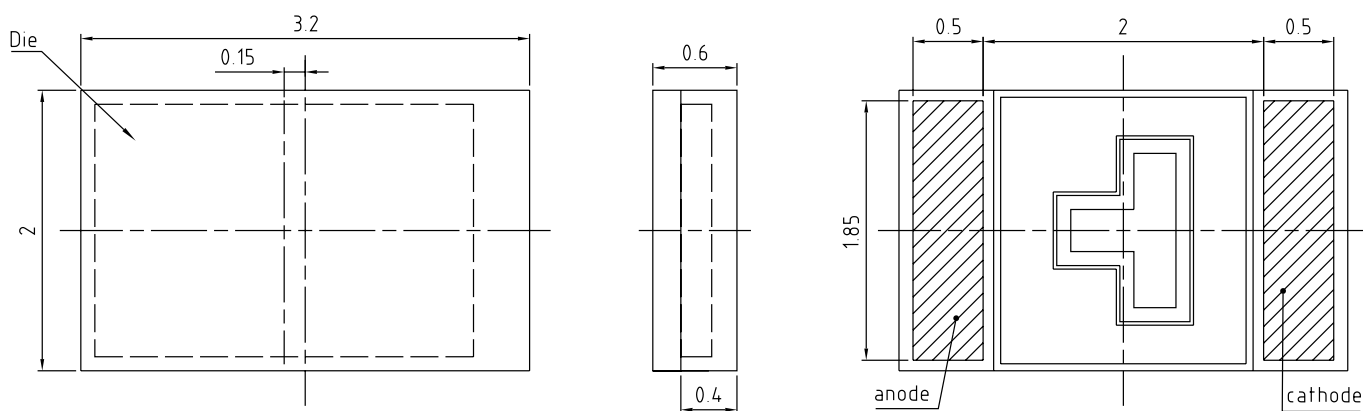

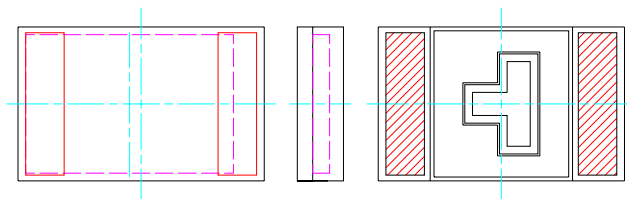

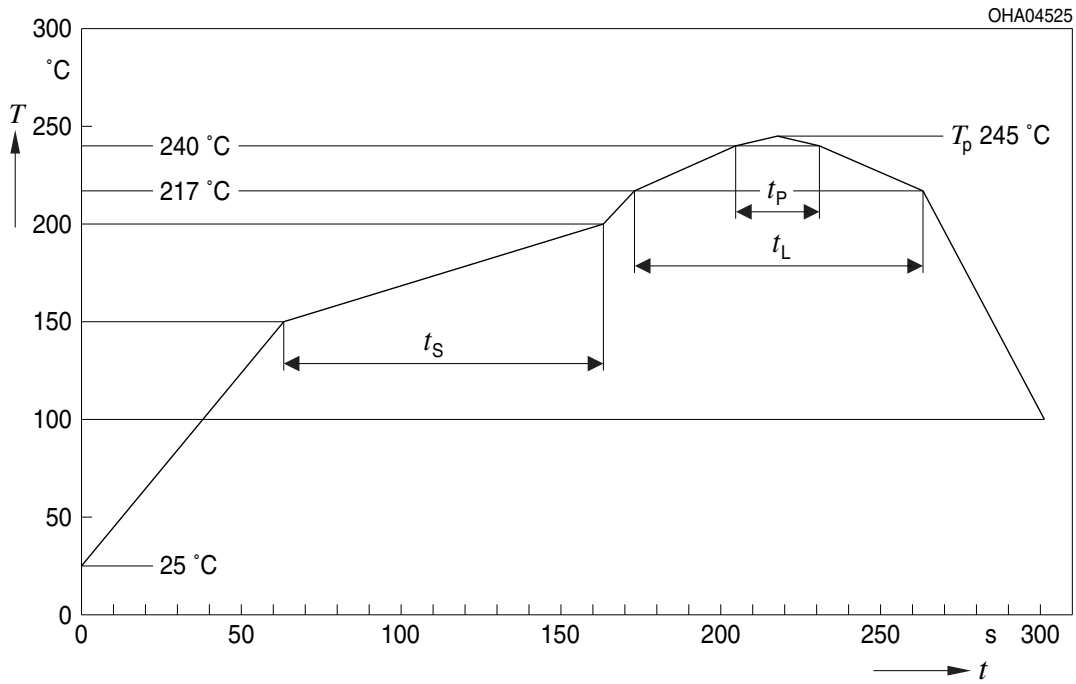
Component Location on Pad

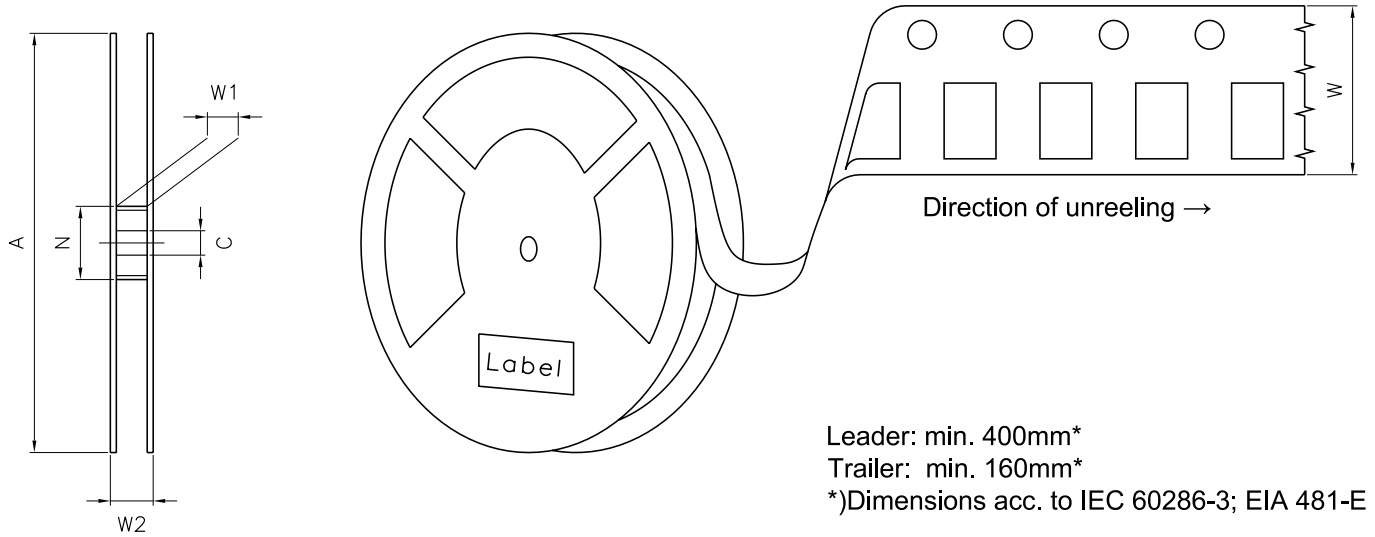

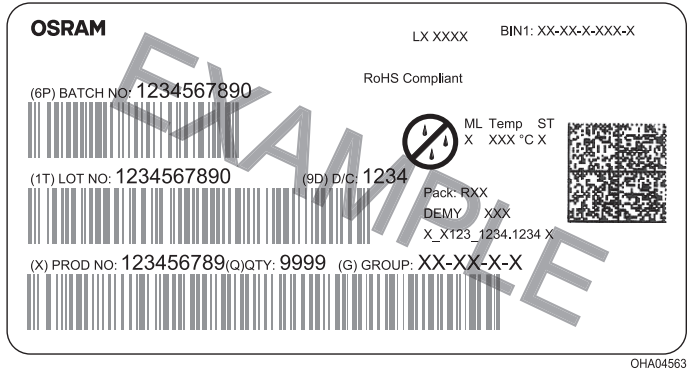

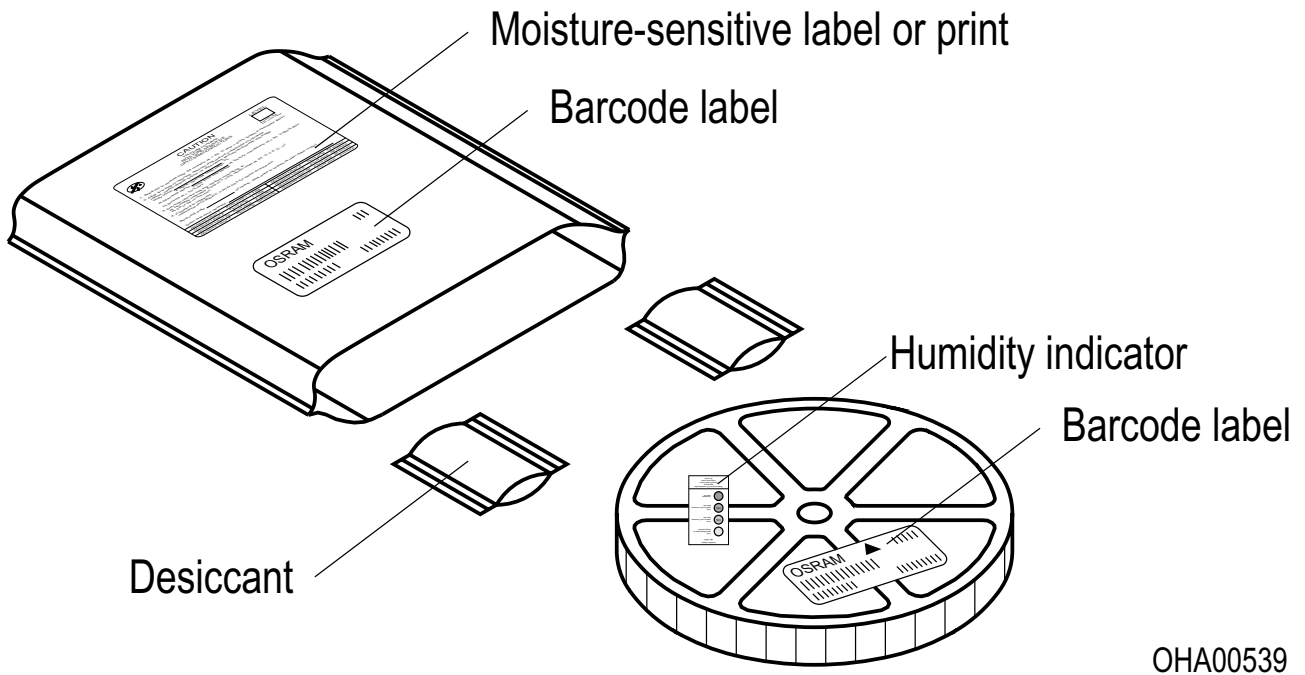
