




#### Radiation Characteristics <sup>8), 9)</sup>




Relative Radiant Intensity<sup>8), 9)</sup>


## Permissible Pulse Handling Capability





#### **Electrical Internal Circuit**




Recommended Solder Pad<sup>10</sup>





#### Tape and Reel <sup>11)</sup>




